The Government of the Republic of the Philippines through the Camarines Norte State College Bids and Awards Committee (BAC) invites contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to apply for eligibility and if found eligible, to bid for the hereunder project:

Contract Duration: 120 Calendar Days

Prospective bidders should possess a valid PCAB License applicable to the contract, and must have an experience of having completed, at least one (1) contract similar to the contract to be bid, and whose value, adjusted to current price using NSO consumer indices, must be at least fifty percent (50%) of the ABC to be bid and have key personnel and equipment (Listed in the Eligibility Forms) available for the execution of the contract. The Eligibility Check or Screening as well as the Preliminary Examination of Bids shall be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act. Post-qualification of the lowest calculated bid shall be conducted.
