Prospective bidders must have an experience of having completed, within a period of five (5) years from the date of submission and receipt of bid, at least one (1) contract similar to the contract to be bid, and whose value must be at least fifty (50%) of the ABC to be bid.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act. The BAC will conduct post-qualification of the lowest calculated bid.

The Approved Budget for the Contract (ABC) is Two Million Five Hundred Eighty-Six Thousand Nine Hundred Fifteen and 50/100 (P2,586,915.50) Pesos.
