6. JVA or the Duly Notarized Statement in accordance with Section 23.1 (b) of this IRR, if applicable;
7. Bid Security in accordance with ITB clause 18, cash, Manager's or Cashier's Check 2% of the ABC or 5% of the ABC in the form of Surety Bond and Bid Securing Declaration


