



Invitation to Bid for the Supply and Delivery of Furniture and Fixtures


1. The CAMARINES NORTE STATE COLLEGE, through the 2019 Income Fund intends to apply the sum of Three Million Five Hundred Eight Thousand Seven Hundred Thirty Seven & 50/100 (Php 3,508,737.50) Pesos being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Furniture and Fixtures. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The CAMARINES NORTE STATE COLLEGE now invites bids for Supply and Delivery of Furniture and Fixtures. Delivery of Goods is required maximum of thirty (30) days. Bidders should have completed from the date of submission and receipt of bids, a contract similar to the Project at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
4. Interested bidders may obtain further information from the HEAD, BAC SECRETARIAT FOR GOODS AND SERVICES, CAMARINES NORTE STATE COLLEGE and inspect the Bidding Documents at the address given below during office hours Monday to Friday.
5. A complete set of Bidding Documents may be acquired by interested Bidders on October 10 to October 31, 2019 from the office of the BAC Secretariat for Goods and Services and upon payment of the non-refundable fee in the amount of Five Thousand Pesos (Php 5,000.00) pesos, pursuant to the latest Guidelines issued by the GPPB at the Cashier’s Office.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The CAMARINES NORTE STATE COLLEGE will hold a Pre-Bid Conference on October 18, 2019 at 9:00 o’clock in the morning at Office of the Vice President for Academic Affairs which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat for Goods and Services at the address below on or before October 30, 2019 at 9:00A.M. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **October 30, 2019 at 9:30 A.M. at Office of the Vice President for Academic Affairs**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **CAMARINES NORTE STATE COLLEGE** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


