1. The Camarines Norte State College - Bids and Awards Committee for Goods and Services (CNSC-BACGS) through the 2019 Income Fund intends to apply the sum tabulated herein being the Approved Budget for the Contract (ABC) to payments under the contract for each lot/item hereunder stated:

The Camarines Norte State College - Bids and Awards Committee for Goods and Services (BAC-GS) now invites bids for one (1) lot for the Supply and Delivery of Various Equipment and Materials, one (1) lot Supply and Delivery of 11 Units High Speed Sewing Machine, one (1) lot Supply and Delivery of One (1) Set Landing Foam, one (1) lot Supply, Delivery and Installation of Furnitures for Chemistry Lab. and one (1) lot Supply and Delivery of Medical and Dental Supplies and Equipment. Delivery of Goods is required to be delivered within thirty (30) days, after the receipt of Notice to Proceed (NTP). Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a Contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass /fail" criterion as specified in the 2016 Revised Implementing

Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Interested bidders may obtain further information from CNSC-BACGS Secretariat, SPMO Office, Gen. Administration Building CNSC, Daet, Camarines Norte and inspect the Bidding Documents at the address given below starting <u>October 17</u>, <u>2019 during office hours.</u>
- 5. A complete set of Bidding Documents maybe acquired by interested bidders on October 17 to November 6, 2019 during office hours from the address below and upon payment at the Cashiers Office, CNSC, Daet, Camarines Norte of the applicable fee for the Bidding Documents, pursuant to the latest guidelines issued by GPPB, in the amount stated above.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- A pre-bid conference will be conducted on <u>October 25, 2019 at 9:00 in the morning</u> at the <u>Office of the Vice President for Academic Affairs</u> which shall be open to all prospective bidders.
- Bids must be duly received by the BAC-GS Secretariat at the address below on or before <u>November 6, 2019, 9:00 AM</u>. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18.

Bid opening shall on November 6, 2019, 9:30 AM at Office of the Vice President for Academic Affairs, 2nd Floor General Administration Building, CNSC, F. Pimentel Avenue, Daet, Camarines Norte. Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

8. In view of the effectivity of the 2016 Revised Implementing Rules and Regulations (IRR) issued by the Government Procurement and Policy Board (GPPB) and the forthcoming issuance by the GPPB of a new and official Public Bidding Documents template, all words, phrases, clauses, and provisions in this Bidding Documents are understood to be read and interpreted in accordance and in conjunction with the 2016RIRR. In case of conflict between this Bidding Documents and the 2016 RIRR

the latter shall prevail. All bidders are presumed to have been apprised of the provisions of 2016RIRR.

- 9. The CNSC BAC for Goods and Services reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
