Invitation to Bid for the Supply and Delivery of Communication Laboratory Equipment's

1. The **CAMARINES NORTE STATE COLLEGE**, through the **2020 Trust Fund** intends to apply the sum of **One Million Two Hundred Thousand (Php 1,200,000.00) Pesos** being the Approved Budget for the Contract (ABC) to payments under the contract for **the Supply and Delivery of Communication Laboratory Equipment's**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **CAMARINES NORTE STATE COLLEGE**, now invites bids for the **Supply and Delivery of Communication Laboratory Equipment's**. Delivery period is within thirty (30) days. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
4. Interested bidders may obtain further information from the **HEAD, BAC SECRETARIAT FOR GOODS AND SERVICES, CAMARINES NORTE STATE COLLEGE** and inspect the Bidding Documents at the address given below during office hours 8:00am – 5:00pm, Monday to Friday.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **February 20, 2020 to March 11, 2020** from the office of the BAC Secretariat for Goods and Services and upon payment of the non-refundable fee in the amount of **Five Thousand Pesos (Php5, 000.00) pesos, pursuant to the latest Guidelines issued by the GPPB** at the Cashier's Office.


It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The **CAMARINES NORTE STATE COLLEGE** will hold a **Pre-Bid Conference** on **February 28, 2020 at 9:00 o'clock in the morning** at **Office of the Vice President for Academic Affairs** which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat for Goods and Services at the address below on or before March 11, 2020 at 9:00 AM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on March 11, 2020 at 9:30 A.M. at Office of the Vice President for Academic Affairs. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **CAMARINES NORTE STATE COLLEGE** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


