CONTRACT AGREEMENT

THIS AGREEMENT made the 19th day of October 2021 between **CAMARINES NORTE STATE COLLEGE (CNSC)** with principal office at **F. Pimentel Avenue, Daet, Camarines Norte** (hereinafter called "the Entity") and **JOYCOM INTERNET CAFÉ** with business address at **Dulong Bayan Ilaod, Brgy 1, Daet, Camarines Norte** (hereinafter called "the Supplier").

 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **Two Hundred Seventy-Three Thousand Four Hundred Twenty Pesos (PHP 273,420.00)** or such other sums as may be ascertained, **JOYCOM INTERNET CAFÉ** agrees to **SUPPLY AND DELIVERY OF IT EQUIPMENT** at CNSC Main Campus, Daet, Camarines Norte in accordance with his/her/its Bid.
4. The **CAMARINES NORTE STATE COLLEGE** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

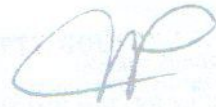

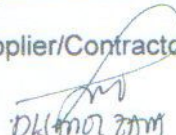
