WHEREAS, the Camarines Norte State College advertised the Invitation to Apply for Eligibility and to Bid for the **COMPLETION OF CENTRALIZED** POWER HOUSE (2MVA WITH PRIMARY AND SECONDARY LINES), Camarines Norte State College-Main Campus, Daet, Camarines published for twenty one (21) days at PHILGEPS, in three (3) Norte conspicuous places at the premises of the Camarines Norte State College, and at CNSC website continuously with Approved Budget for the Contract (ABC) in the amount of Fourteen Million, Seven Hundred Ninety-Nine Thousand, Nine Hundred Ninety-Four Pesos and 71/100 (P14,799,994.71) charged in the 2021 GAA Funds;

WHEREAS, in response to the said advertisements, there were two (2) interested bidder that acquired bid documents;

WHEREAS, there were two (2) interested bidder submitted bid on December 5, 2022 at 1:40 in the afternoon and declared eligible to participate in the bidding;
