1. The **CAMARINES NORTE STATE COLLEGE**, through its Bids and Awards Committee invites bidders to bid the hereunder projects:

**Lot 1 – REFURBISHMENT OF STUDENT KIOSKS AT CENTRAL GARDEN – MAIN CAMPUS,**  
Camarines Norte State College, Main Campus, Daet, Camarines Norte.

**Lot 2 – REPAIR OF ROOF AND CEILING OF VARIOUS BUILDINGS AT CNSC MAIN CAMPUS,** Daet,  
Camarines Norte.

**Lot 3 – REPAIR AND REHABILITATION OF COMFORT ROOMS (GRADUATE SCHOOL URINAL AND WATER CLOSET),** Camarines Norte State College, Main Campus, Daet, Camarines Norte.

**Lot 4 – SUPPLY, INSTALLATION, REPAIR AND RESTORATION OF DOORS AND WINDOWS FOR GS BUILDING,** Camarines Norte State College, Main Campus, Daet, Camarines Norte.

2. The total **Approved Budget for the Contract (ABC)** inclusive of all applicable taxes and other charges is in the amount of **Two Million, One Hundred Twenty Six Thousand, Eight Hundred Fifty Six Pesos and 32/100** (₱ 2,126, 856.32) with the following details:

**Lot 2 – Fifty Three Thousand, Eighty Six Pesos and 62/100** (₱ 53,086.62)

**Lot 3 – Three Hundred Eighty Thousand, One Hundred Thirty-Nine Pesos and 40/100** (₱ 380,139.40)

**Lot 4 – One Hundred Ninety-Nine Thousand, Two Hundred Thirty Nine Pesos and 85/100** (₱ 199,239.85)

Bids received in excess the amount per lot and lumped into one (1) bid shall be automatically rejected at bid opening, or during bid evaluation.

payment of non-refundable fee pursuant to the latest Guidelines issued by the GPPB in the amount of **Five Thousand Pesos (₱ 5,000.00)**. CNSC shall allow the bidder to present its proof of payment for the fees by presenting the original copy of the official receipt or through electronic mail.

The **CAMARINES NORTE STATE COLLEGE** will hold a Pre-Bid Conference on **September 9, 2024** at the **Office of the Vice President for Administration and Finance, 2<sup>nd</sup> Floor, Central Business Processing Center (New Admin Building), CNSC Main Campus, Daet, Camarines Norte** at exactly **2:00 o'clock in the afternoon** which shall be open to prospective bidders.
6. Bids must be duly received by the BAC Secretariat through manual submission on **September 23, 2024 on or before 1:30 in the afternoon** at the Head, BAC Secretariat Office, 2<sup>nd</sup> Floor, GASS Building, CNSC Main Campus, Daet, Camarines Norte. Late bids shall not be accepted.
7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
8. Bid opening shall be on **September 23, 2024** at exactly **2:00 o'clock in the afternoon** at the **Office of the Vice President for Administration and Finance, 2<sup>nd</sup> Floor, GASS Building, CNSC Main Campus, Daet, Camarines Norte**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **CAMARINES NORTE STATE COLLEGE** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.


