BAC Resolution Declaring SCRB and Recommending for the Award

WHEREAS, the Camarines Norte State College advertised the Invitation to Apply for Eligibility and to Bid for the **CONSTRUCTION OF TWO BUILDING THREE STOREY COTT ACADEMIC BUILDING COMPLEX-PHASE 2 (LOT 1-INFRASTRUCTURE), Camarines Norte State College-COTT, Orange Hill, Jose Panganiban, Camarines Norte** published for twenty one (21) days at PHILGEPS, in three (3) conspicuous places at the premises of the Camarines Norte State College, and at CNSC website continuously with Approved Budget for the Contract (ABC) in the amount of **Forty One Million, Six Hundred Eighteen Thousand, Five Hundred Nineteen Pesos and 99/100 (P 41,618,519.99) charged in the 2025 GAA Fund;**

WHEREAS, in response to the said advertisements, there were three (3) interested bidders that acquired bid documents;

WHEREAS, there were two (2) interested bidders submitted bid as follows, viz:

WHEREAS, the two (2) bidders were declared eligible to participate in the bidding;

WHEREAS, the bid proposal of only one (1) bidder was found to be substantially complying;

WHEREAS, the detailed evaluation of bids conducted on **January 10-15, 2025** the single calculated bid was as follows:

JVM CONSTRUCTION AND SUPPLY CEGUERA AND	4,008,949.07	90.37%-DISQUALIFIED due to following reasons: 1. The submitted SLCC was not within five (5) years of 'completion wherein the required period set by the BAC in accordance with the provision in the ITB. 2. The amount per item in the BOQ stated in words for nearly all items were inconsistent with the corresponding figures indicated in the document. In accordance with the provision of RA 9184 words will prevail over figures, the total bid amount was found to be significantly lower in the amount of Four Million, Eight Thousand, Nine Hundred Forty Nine Pesos and 07/100 (P4,008,949.07), rendering, most of the work included in the project are technically not feasible to accomplish.
AVZ CONSTRUCTION AND SUPPLY	41,608,209.75	0.02% - Single Calculated Bid

WHEREAS, upon careful examination, validation, and verification of all the eligibility, technical and financial requirement submitted by the Bidder who was post qualified on **January 31, 2025** had been found to be responsive.
